This is an application made under Section 438 Cr.P.C., seeking pre-arrest bail by the petitioners, namely, 1. Bikramjit Singha, 2. Kiranjit Singha, 3. Panthio Devi and 4. Neva @ Niva Rani Devi, apprehending arrest in connection with Silchar Police Station Case No. 1893/2019, registered under Sections 147/447/427/294/354/379 of the IPC.

I have perused the petition including the copy of the FIR and the documents annexed therewith.

Heard Ms. HRA Choudhury, learned senior counsel for the petitioners as well as Mr. B Sarma, learned Additional Public Prosecutor, appearing for the State of Assam.

Mr. Sarma, learned Additional Public Prosecutor submits that in the instant case, Final Report, vide F.R. No. 917 /2018, dated 30-06-2019, has already been laid by the Investigating Police Officer, after completion of investigation of the case.

That being so, no cause of action for this pre-arrest bail survives.

Accordingly, this anticipatory bail application stands closed.

Interim pre-arrest bail granted to the petitioners, vide order, dated 28-06-2019 accordingly stands vacated.
