Heard Mr. N.N. Upadhyaya, the learned counsel for the applicant, who submits that the applicant by filing this application seeks the suspension of the Order of conviction passed by the learned Addl. District & Sessions Judge, Dibrugarh in Criminal Appeal No. 58(4)/2017 by which, the Judgment & Order dated 19.12.2017 passed by the learned CJM, Dibrugarh in Criminal Case No. 331/2012, in so far as the conviction is concerned was maintained.
