Heard Md. B Islam, learned counsel for the accused-petitioner. Also heard Mr. B Sarma, learned Additional Public Prosecutor, appearing for the State of Assam.

This is an application, filed under Section 438 of the Cr.PC. seeking pre-arrest bail of the accused-petitioners, namely, 1. Soleman Ali @ Solemon Sheikh, 2. Rohima Khatun @ Ahima Bibi, 3. Omed Ali and 4. Samsher Ali, in connection with Bilasipara P.S. Case No. 862/2019 registered under Sections 384/506/34 of the IPC.

Perused the case diary produced before this court.

On perusal of the materials in the case diary, it does not appear to this court that there is any such material requiring custodial interrogation of the accused-petitioners.

The petitioners are already on interim pre-arrest bail granted vide order, dated 30.09.2019. There is no instance to indicate that during this period, the petitioners have misused the liberty granted to them while availing interim pre-arrest bail. In the meantime, the petitioners have appeared before the Investigating Police Officer and got their statements recorded.

In view of the above facts, this court is inclined to grant the privilege of pre-arrest bail to the petitioners and accordingly, the interim pre-arrest bail granted to the accusedpetitioners, on 30.09.2019, is made absolute on the same terms and conditions.
