Heard Mr. H.J. Tamuli, learned counsel for the petitioners and Ms. M. Hazarika, learned Senior counsel for the respondent.

This petition has been filed alleging willful and deliberate violation of the order dated 12.03.2018 passed in WP(C) No.1328/2018.

As per the order dated 12.03.2018, Commissioner, North Assam Division was directed to decide the application of the petitioners dated 01.08.2017 filed under Section 3(G)(5) of the National Highways Act, 1956 within six months.

Ms. Hazarika submits that order has been passed by the respondent on 30.05.2019 rejecting the application dated 01.08.2017.

A copy of the said order has been furnished to learned counsel for the petitioners.

It is open to the petitioners to avail their remedy against such decision in accordance with law, if so advised.

Contempt proceeding is dropped.
