JUDGMENT

- 1. The grievance projected by the petitioner no. 1 in this petition is that she came to be deployed in Government Middle School, Khanpora, Budgam on health grounds vide order No. CEOB/Estt/7900-A passed by Chief Education officer, Budgam and was later allowed to continue in Middle School Housing Colony Ompora Zone Budgam vide Orde No. Estt-III/B-Trs/Deploy/16/2018/2779 dated 30.07.2018 issued by Personnel Officer Directorate of School Education Kashmir.
- 2. The case set up by petitioner no. 2 in this petition is that she was transferred from GPS Khoja Mohalla, Nowlaru Zone Pattan District Baramulla to District Budgam on marriage grounds by virtue of order No. Edu/I/703/2017 dated 23.02.2018 passed by Secretary to Government School Education Department and came to be posted in MS Housing Colony, Ompora.
- 3. Petitioners claim that respondent no. 5 has issued Order vide No. ZEO/B/228 dated 23.05.2019, whereby among others, petitioners have been relieved from their present place of

deployment/posting. It is submitted that the respondent no. 5 has

not taken into consideration that the deployment of the petitioner

no. 1 was on health grounds and the posting of petitioner no. 2 was

duly approved by the administrative department on marriage

grounds.

3. Having heard learned counsel for the petitioners and perused

the record.

4. This petition in the given facts and circumstances is disposed

of at this stage by providing that the respondent no. 1 shall look

into the grievance of the petitioners as projected by them in this

writ petition and pass appropriate orders therein as may be

warranted. It would be appropriate, if the petitioners make formal

representations to the respondent no. 1 projecting their grievance

5. Let the decision in this regard by respondent no. 1 be taken

within a period of four weeks from the date he receives the

representations along with the copy of this order from the

petitioners. Petitioners shall ensure that they make representations

and also supply copy of this order to respondent no. 1 within

week's time.

6. Till a decision in this regard is taken by the respondent no. 1,

the present status of the petitioners shall not be disturbed.

7. **Disposed of** as above along with connected CM(s).
