Petitioner is accused in Chandil P.S. Case No. 36 of 2015, corresponding to G.R. No. 339 of 2015, registered for the offence under Sections 323, 341, 307, 120-B of the Indian Penal Code and Section 27 of the Arms Act.

It appears that under order dated 26.03.2019, status report of the case was called for.

Perused the report dated 30.03.2019 submitted by Sessions Judge, Seraikella-Kharsawan, which reveals that the records were received in the court file of learned Sessions Judge on 28.03.2019. Production warrant has already been issued against accused and the next date fixed for production of the accused on 09.04.2019.

Today, when the case is called out, learned counsel for the petitioner has produced the order dated 25.04.2019 passed by learned Sessions Judge, Seraikella-Kharsawan. From perusal of order dated 25.04.2019, it appears that charges under Sections 341, 323, 307, 120(B) of the I.P.C. and Section 27 of the Arms Act has been framed against the petitioner.

It is submitted that petitioner was absconder in this case and further co-accused who has faced the trial in S.T. No. 61 of 2016 have been acquitted vide judgment dated 05.12.2018 by learned Sessions Judge, Seraikella-Kharsawan. Copy of the judgment has been filed.

Learned A.P.P. opposed the prayer for bail.

Be that as it may, I am inclined to admit the petitioner on bail. Accordingly, the petitioner is directed to be released on bail on furnishing bail bonds of Rs. 25,000/- (Rupees Twenty Five Thousand) with two sureties of like amount each to the satisfaction of learned Principal District & Sessions Judge, Seraikella, in connection with Chandil P.S.

Case No. 36 of 2015, corresponding to G.R. No. 339 of 2015 subject to the condition that petitioner shall deposit Rs. 1500/- by way of cost in the account of **Army Welfare Fund Battle Casualties being A/C No. 90552010165915, IFSC Code - SYNB0009055, Syndicate Bank, Branch - South Block, Defence Headquarter, New Delhi, Branch Code-9055** and will submit a receipt of the aforesaid deposition before the court below at the time of furnishing bail bonds.

Let a copy of order be also communicated to the trial court and also handed over to learned counsel for the petitioner.
