**CORAM : HON'BLE MR. JUSTICE ANANDA SEN.**

03/28.02.2019: In this writ petition, the petitioner has prayed for grant of the benefit of Super Selection Grade in the pay scale of Rs.2200-4000/- .

2. Counsel for the petitioner submits that the petitioner was appointed as an Assistant Teacher in Gandhi Smarak High School, Sijua on 1.8.1961 and was granted the B.A. Trained Scale with effect from 1.4.1977. He further submits that the petitioner has superannuated on 31.9.1994. He also submits that though the petitioner was recommended for the Super Selection Grade in the pay scale of Rs.2200-4000/- but the said benefit has not been extended to him. In support of his contention, he also relies upon Annexure-2, issued by the District Education Officer, Dhanbad dated 15.7.2003, which is in favour of the petitioner. He lastly submits that the petitioner is entitled to the aforesaid benefits as other similarly situated persons have been granted the said benefit.

3. Counsel for the State submits that the petitioner has approached this Court without making any representation before the authority concerned. He further submits that if the petitioner files any application, the same will be considered as per law and circular.

4. Accordingly, I direct the petitioner to file a detailed representation ventilating his grievance before respondent No.3- the Director, Human Resources Department, Primary Education, along with a copy of this order within four weeks from today. On receipt of such representation, respondent No. 3 will consider the claim of the petitioner as per law and the circular and will pass a reasoned order. The entire exercise should be concluded within 16 weeks from the date of receipt of representation along with a copy of this order.

5. If any portion of the claim of the petitioner is denied or disputed by the respondent(s), the reasons for such denial, should be communicated to the petitioner within the said period.

6. With the aforesaid observation and direction, this writ petition stands **disposed of**.
