**Order No.02 Dated- 29.08.2019**

Apprehending their arrest in connection with Nimdih P.S. Case No.28 of 2019 (P.C. Case No.213 of 2016) instituted under Sections 418/420/120-B of the Indian Penal Code, the petitioners have moved this Court for grant of privileges of anticipatory bail.

Heard learned counsel appearing for the petitioners and learned A.P.P appearing for the State.

Learned counsel appearing for the petitioners submits that the allegation against the petitioners is that the petitioner No.1 was pregnant before her marriage with the informant and suppressing the said fact, her marriage was solemnized with the informant. It is submitted that the allegation against the petitioners is false. It is then submitted that the informant used to visit the house of the petitioner No.1 one year before her marriage and established physical relationship with the petitioner No.1 with the assurance of marriage and as the petitioner No.1 became pregnant, the informant married her and subsequently on 14.05.2015, a formal marriage was also solemnized and after the birth of the child, the informant and his family members drove the petitioner No.1 out from their house and they were demanding dowry amount of Rs.60,000/-, hence, to harass her this false case has been foisted. It is lastly submitted that the petitioners are ready and willing to co-operate with the investigation of the case. Hence, it is submitted that the petitioners be given the privileges of anticipatory bail.

Learned A.P.P appearing for the State opposes the prayer for anticipatory bail of the petitioners.

Considering the submissions of learned counsels and the facts and circumstances stated above, I am inclined to grant privileges of anticipatory bail to the petitioners. Accordingly, the petitioners are directed to surrender in the

Court of learned Additional Chief Judicial Magistrate at Seraikella within four weeks from today and in the event of their arrest or surrendering, they will be enlarged on bail on furnishing bail bond of Rs.25,000/- (Twenty five thousand) each with two sureties of the like amount each to the satisfaction of learned Additional Chief Judicial Magistrate at Seraikella in connection with Nimdih P.S. Case No.28 of 2019 (P.C. Case No.213 of 2016) **with the condition that they will co-operate with the investigation of the case and appear before the investigating officer as and when noticed by him and furnish their mobile number and photocopy of the Aadhar Card with an undertaking that they will not change their mobile number during the pendency of the case** and subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure.
