# Hon'ble Shri Justice Gautam Chourdiya Order on Board

- 1. With the consent of the parties, the matter is heard finally at the admission stage itself.
- 2. Learned counsel for the petitioners submits that the case of the petitioner is squarely covered by the decisions of this Court dated 01/05/2019 in WPS No. 3204/2019 in Sangeeta Sinha Vs. State of Chhattisgarh & Others and, therefore, the present petitions may be disposed off in terms of the aforesaid order.
- 3. Learned counsel for the State has no objection to the above proposition of the petitioners.
- 4.
