This review petition has been filed for restoration of Arbitration

Case No.85/2018 (M/s Essar Power M.P. Limited Vs. M.P. Power

Management Company Limited) which was dismissed on merit vide

order dated 21.08.2019 in the absence of the counsel appearing for the

applicant.

Learned counsel for the applicant has submitted that the aforesaid

application was dismissed observing that the counsel for the applicant

did not appear despite intimation. An affidavit to this effect in the present

petition is filed by the counsel for the applicant that he would not be

intimated and has submitted that he could not advance his arguments due

to his non-appearance as he would not be intimated and certain relevant

documents/facts which could have been brought by the applicant was not

brought on record.

Learned counsel for the respondent has opposed the prayer and has

submitted that no case for review of order dated 21.08.2019 passed in

R.P. No.85/2018 is made out as the order is passed on merit as also

taking note of the fact that the matter is still pending between the parties

before the Madhyastham Adhikaran/M.P. Arbitration Tribunal.

Having considered the rival submissions and taking note of the fact

that the counsel for the applicant was not present on 21.08.2019 before

the Court and counsel for the respondent has not filed any document on

record to show the aforesaid fact.

so that amount can be utilized for a National Cause, and its receipt be

produced before the Registry of this Court.

Let a copy of this order be retained in the file of A.C. No.85/2018.

Subject to deposit of aforesaid cost, the order dated 21.08.2019

passed in A.C. No.85/2018 is hereby recalled and after filing its receipt

before the Registry of this Court, Office shall restore A.C. No.85/2018 to

its original number and list A.C. No.85/2018 in the week commencing

from 11th of November, 2019.
