**CRIMINAL PETITION No.2012 OF 2019**

**ORDER:**

This petition is filed under Section 482 of the Code of Criminal Procedure, 1973, seeking to set aside the order dated 07.3.2019, passed in Crl.M.P. No.824 of 2019 in C.C. No.418 of 2017 on the file of the Court of Additional Judicial First Class Magistrate, Nandigama, by virtue of which the petition filed by the petitioner, who is the accused, under Section 311 Cr.P.C., to recall P.Ws.1 and 7 for further cross-examination, was dismissed, on the ground that the petition was filed at belated stage.

2. Heard the counsel for the petitioner and the learned Public Prosecutor appearing for the respondent.
3. The counsel for the petitioner submits that the wound certificate pertaining to P.W.1 was filed only through the Investigating Officer, who was examined as P.W.7. He further submits that unless P.Ws.1 and 7 are cross-examined, with regard to the contents of wound certificate, the said documents cannot be marked, and hence, he seeks to recall P.Ws.1 and 7. This Court finds force in the said contention, as the wound certificate cannot be marked, unless P.Ws.1 and 7 are cross examined by the defence.
4. Hence, considering the above, this Court is considered opinion that it is a fit case to set aside the impugned order.

5. In view of the above, the Criminal Petition is allowed, setting aside the order dated 07.3.2019, passed in Crl.M.P. No.824 of 2019. Consequently, Crl.M.P. No.824 of 2019 in C.C. No.418 of 2017 on the file of the Court of Additional Judicial First Class Magistrate, Nandigama, is allowed. As a sequel, the miscellaneous applications pending, if any, shall stand closed.
