THE HON'BLE THE ACTING CHIEF JUSTICE C. PRAVEEN KUMAR CIVIL REVISION PETITION No.7680 of 2018

ORDER:

- The present revision petition came to be filed by the petitioner assailing the order dated 13.8.2018 in I.A.No.790 of 2018 in MVOP No.228 of 2018, wherein the learned Motor Accidents Claims Tribunal-cum-Principal District Judge, Krishna, Machilipatnam, while directing release of the vehicle, imposed certain conditions.
- 2. The learned Counsel for the petitioner submors that the petitioner is the owner of the vehicle in question, which was purchased about three and half years back. He submits that the condition imposed by the Court below in directing the petitioner to furnish bank guarantee of Rs.4,50,000/- would virtually amount to denial of relief to the petitioner, since it is very difficult for him to secure bank guarantee for the said amount.
- 3. It is not in dispute that the perimoner is the owner of the vehicle and the vehicle in question is a goods carriage of the year 2015. He pleads that if the vehicle is exposed to sun and rain, there is every possibility of vehicle getting damaged.
- 4. Having regard to the above circumstances, the petitioner is directed to furnish bank guarantee of Rs.1,50,000/- Rupees One Lakh and Fifty Thousand only) with one surety for the like sum, to the satisfaction of the Additional Judicial Magistrate of First Class, Avanigadda, instead of bank guarantee of Rs.4,50,000/-, which directed to be furnished by the Court below. It is made clear that on release of vehicle, the petitioner shall not alienate the vehicle in

question or create any third party rights thereon. All other conditions shall remain unaltered.

 Accordingly, the Civil Revision Petition is disposed of modifying the order impugned to the extent indicated above. No costs.
 Consequently, miscellaneous petition pending, if any, shall stand closed.
