ORDER

All the petitioners being the employees of the 3rd respondent-Society now in liquidation have filed this writ petition seeking a mandamus to the 2nd respondent-Official Liquidator to consider their representations dated 27.6.2018/29.6.2018 which are serially produced at Annexures-C1 to 17 and to pay them the allowances for the loss of future services.

2. After service of notice, the 1st respondent is represented by Mr.C.N.Mahadeshwaran, learned Addl. Govt. Advocate; the 2nd respondent-Official Liquidator being personally present before the Court submits that there would be no difficulty in considering the petitioners subject representation in terms of Government Order containing priority list and in accordance with law.

Keeping the above submission on record, these writ petitions are disposed off. All other contentions of the parties are kept open.
