ORDER

This petition is filed on the ground that the interim order dated 03.12.2018 and extension of time dated 19.12.2018 passed in Writ Petition No.53791 of 2018 by the learned Single Judge, has been disobeyed.

2. The accused is present. She has filed her affidavit explaining the circumstances involved in the case.

She has also tendered her apology for violating the interim order passed by this Court.

3. We have considered the affidavit and the interim order and the manner in which the proceedings have been going on and also the fact that the writ petition was rejected and the writ appeal have also been dismissed. Notwithstanding the extension of time, even though the interim order was granted, no positive act has been done. Therefore, keeping all these circumstances in mind and in view of tendering of an unconditional apology, we deem it just and appropriate to accept the same.

Hence, the proceedings are dropped.
