THIS WRIT PETITION IS FILED UNDER ARTICLES 226 & 227 OF THE CONSTITUTION OF INDIA, PRAYING TO CALL FOR THE RECORDS; DIRECT THE R-1 AND 2 TO HOLD THE ELECTION TO THE MANAGING COMMITTEE OF THE IDGAH, MASJID AND MADARASHA AND THE KHABRASTAN SITUATED AT JAYANAGAR 4TH BLOCK, BENGALURU TO ALLOT AND TO ORDER FOR ENQUIRY INTO THE MISDEEDS OF THE COMMITTEE OF MANAGEMENT IN THE AFFAIRS O`F JAMIA MASJID-E-ISLAMABAD BASAVANAGUDI.

THIS WRIT PETITION COMING ON FOR *ORDERS* THIS DAY, THE COURT MADE THE FOLLOWING:-

ORDER

In this petition, the petitioner *inter alia* seeks for a direction to the respondent Nos.1 and 2 to hold the election to the Managing Committee of the Idgah, Masjid and Madarasha and the Khabrastan situated at Jayanagar 4th Block, Bengaluru to allot and to order for enquiry into the misdeeds of the Committee of Management in the affairs of Jamia Masjid-e-Islamabad, Basavanagudi.

2. On perusal of the records, I deem it appropriate to dispose of the writ petition with liberty to the petitioner that in case a fresh representation is made by him to the competent authority with regard to his grievance within a period of two weeks from the date of receipt of the certified copy of the order passed today, the same shall be dealt with by the competent authority in accordance with law by a speaking order within a period of four months from the date of receipt of such representation. Ordered accordingly.

3. It is made clear that this Court has not expressed any opinion on the merits of the case.

Accordingly, the petition is disposed of.
