This Writ Petition is filed under Articles 226 and 227 of the Constitution of India, praying to direct the Chief Returning Officer of respondent No.2 Society, Bengaluru and Co-operative Development Officer in the office of Co-operative Societies registered office, 3<sup>rd</sup> Range, Bengaluru Urban District to correct the voter list by collecting the proper address of the members who are shown care of address shown in the members list of the R-2 Society and etc.

This Writ Petition coming on for Preliminary Hearing this day, the Court made the following:

**O R D E R**

The petitioner has sought for a direction to the Chief Returning Officer of respondent No.2 society, Bengaluru and Co-operative Development Officer in the office of Co-operative Societies Registered Office, 3<sup>rd</sup> Range, Bengaluru Urban District to correct the voters list of the respondent No.2-Society by collecting the proper address of the members whose addresses are shown as care of address *inter alia* seeking a direction to the returning officer of the respondent No.2 society not to hold the election process in respect of respondent No.2 society, till the list of the members are corrected.

2. The petitioners claiming to be the members of the respondent No.2 society are before this Court alleging certain irregularities in the list of members prepared by the respondent No.2 society inasmuch as reflecting the address of certain members as 'care of address' not reflecting the correct addresses.

3. It is not in dispute that in terms of the notification issued by the respondent No.2, the calendar of events has been notified on 28.12.2019. On notifying the calendar of events, the petitioners are now seeking for postponement of the election of the respondent No.2 society. Merely on the allegation made that no correct address of the members have been furnished in the list of addresses of the members, at this stage, no election process can be stalled. If the petitioner is aggrieved by the irregularities in conducting the election, they are at liberty to take recourse to the alternative and efficacious statutory remedy available under law.

Accordingly, writ petition stands disposed of.
