ORDER

The prayer in this Transfer Petition is to transfer O.P. No.1059 of 2018 on the files of the Family Court, Irinjalakuda to the Family Court, Thalassery for the trial and disposal in accordance with law.

2. Service is complete. However, there is no appearance for the respondent.

3. Heard the learned counsel for the petitioner.

4. The petitioner is the wife. She has no job or other source of income for her livelihood. The petitioner is residing in Kannur District. There is nobody to accompany the petitioner to the Family Court, Irinjalakuda. That apart, she has to bear the travelling expenses for her journey from her house in Kannur to the Family Court, Irinjalakuda. So also, connected O.P. No.911 of 2018

and M.C. No.445 of 2018 are pending before the Family Court, Thalassery. Since connected matters are pending before the Family Court, Thalassery, I am of the view that it will be convenient to both sides if the above case is transferred to the Family Court, Thalassery. In the said circumstances, I am inclined to allow this transfer petition.

In the result, this Transfer Petition stands allowed, transferring O.P.No.1059 of 2018 on the files of the Family Court, Irinjalakuda to the Family Court, Thalassery, for the trial and disposal, in accordance with law.

The case records shall be transmitted to the transferee court forthwith.

The petitioner shall appear before the transferee court on 19.12.2019 without further notice.
