The prayers in this Writ Petition (Civil) are as follows:

- “i. *a writ of mandamus or any other appropriate writ order or direction to the respondents to dispose the SM No.968/2018 as evidenced by Ext.P1 within a reasonable time.*
ii. *Such other reliefs as this Hon'ble Court deems fit to grant in the nature of this case.” .*

2. Heard Sri.U.K.Devidas, learned counsel for the petitioner and Smt.Priya Shanavas, learned Govt. Pleader appearing for the respondents.

Taking note of the facts and circumstances, it is ordered in the interest of justice that the Land Tribunal concerned will take all the reasonable endeavours possible under the circumstances to ensure early consideration and disposal of S.M. Proceedings involved in this case as per S.M.No.968/2018 without much delay, preferably within a period of 16 months from the date of completion of service of notice on the affected parties.
