## **JUDGMENT**

The petitioner is a stage carriage operator on the route Pilathara-Payyannur-Puthiyapuzhakkara in respect of stage carriage bearing registration No.KL-13/K-8386, who has been granted variation vide Ext.P2 proceedings dated 27.09.2018 of the Regional Transport Officer, Kannur. Now the petitioner is before this Court in this writ petition under Article 226 of the Constitution of India seeking a writ of mandamus commanding the respondent to issue the varied permit granted as per Ext.P2 to the petitioner in respect of the said stage carriage with tentative set of timings suggested by him without any delay.

2. Heard the learned counsel for the petitioner and also the learned Senior Government Pleader appearing for the respondent.

3. The learned Senior Government Pleader, on instructions, would submit that the request made by the petitioner for settlement of timings of the varied permit granted in respect of his stage carriage bearing registration

No.KL-13/K-8386, based on Ext.P2 proceedings of the Regional Transport Authority will be considered in the timing conference scheduled to be held on 17.04.2019.

4. Having considered the submissions made by the learned counsel on both sides, this writ petition is disposed of by recording the submission made by the learned Senior Government Pleader that the request made by the petitioner for settlement of timings of the varied permit granted as per Ext.P2 proceedings of the Regional Transport Authority shall be considered by the respondent in the timing conference scheduled to be held on 17.04.2019.

Consequential proceedings shall be issued by the respondent to the petitioner, without any delay.
