THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 30.04.2019, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

### JUDGMENT

The petitioner, who is employed abroad, has filed this Writ Petition through his Power of Attorney holder, who is his father, seeking release of the vehicle bearing Regn.No.KL-56A-9009 involved in Crime No.135/2018 of Mananthavady Police Station for having allegedly committed offence punishable under Section 420 of the Indian Penal Code. The vehicle was directed to be released to the petitioner on execution of bond, by the Judicial First Class Magistrate-II, Mananthavady vide Ext.P2 order dated 6.6.2018 in Crl.MP No.1254/2018. But, it is stated that the Police are insisting on the petitioner himself being present for execution of the bond.

2. The learned counsel for the petitioner relies on a judgment of this Court in *Itty Type v. State of Kerala [WP(C) No.26366/2009]* for the proposition that the vehicle can be released to the Power of Attorney holder in the absence of the registered owner. It is submitted that the registered owner in this case is employed abroad and he cannot be expected to come for getting release of the vehicle. In view of the above, this Court is of the

opinion that there is no harm in the Power of Attorney holder, who is his own father, representing him to apply for release of the vehicle.

3. In the result, this Writ Petition is disposed of directing that the vehicle bearing Regn.No.KL-56A-9009 involved in Crime No.135/2018 of Mananthavady Police Station, shall be released as ordered by the Judicial First Class Magistrate-II, Mananthavady in Ext.P2 order dated 6.6.2018 in Crl.MP No.1254/2018, if the registered owner or the Power of Attorney holder of the registered owner executes the bond as mentioned in Ext.P2 order.
