JUDGMENT

The petitioner prays for the following reliefs:

- “i) Issue a writ of mandamus or appropriate writ, order commanding the respondent to refund the Motor vehicle Tax in respect petitioner's stage carriage bearing No.KL 40/M 9100 collected as per the floor area rate for the period from 01.11.2016 to 30.09.2018 or adjust the excess amount collected for the above period towards the tax payable by the petitioner for the same vehicle for the future periods*
- ii) grant the petitioner such other reliefs which this Honourable court deem just and fit in the circumstances of the case.”*

2. Sri.O.D Shivadas does not press the writ prayer but states that the petitioner is satisfied if Ext.P2 is considered by the respondent and disposed of expeditiously. By referring to the statement made by him the following order is made.
