THE COURT ON THE SAME DAY PASSED THE FOLLOWING:

O R D E R

The petitioner is the 2nd accused in Crime No.431/2019 of Parassala Police Station for offences punishable under Sections 420, 406, 468, 471 read with Section 34 Indian Penal Code.

2. The prosecution case in brief is that in furtherance of the common intention with the 1st accused, who is none other than her husband, petitioner was conducting an institution, in which job was offered to the nursing graduates in .. and under the guise of such offer, amounts were collected from various persons.

3. Altogether four cases were registered against the petitioner and in one of the cases the petitioner has been granted anticipatory bail in Crime No.1427/2018 at Kuruvilangad Police Station. The petitioner was arrested in this case on 01.04.2019 and was remanded to judicial custody.

3. Heard both sides.

Considering the fact that the petitioner has

been in judicial custody since 01.04.2019 and that the presence is not required in connection with the further investigation in this case, it is just and proper to grant bail to the petitioner on the following conditions:

- i) The petitioner shall execute a bond for Rs.50,000/- (Rupees Fifty thousand only) with two solvent sureties each for the like amount to the satisfaction of the Magistrate's court concerned.
- ii) The petitioner shall appear before the Investigating Officer between 9 a.m. and 11 a.m. on all Mondays and Thursdays for a period of three months after being released on bail.
- iii) The petitioner shall not in any manner intimidate or influence the prosecution witnesses. He will not in any manner contact or try to contact the victim or her family members, even over phone or otherwise.

- iv) The petitioner shall surrender his passport in the Magistrate's court/jurisdictional court concerned within three days of his release on bail. If he does not possess any passport, he shall file an affidavit to that effect in that court within that period.
- v) The petitioner shall not leave the State of Kerala without the prior permission of the jurisdictional court concerned.
- vi) If the petitioner violates any of the conditions of bail, it is open to the Court having jurisdiction over the case to cancel his bail without any further orders from this Court but in accordance with law.
