ORDER

The petitioners are accused Nos. 1 to 4, 6 and 7 in Crime No. 15 of 2019 of Koyilandy Police Station, registered for the offences punishable under Sections 143, 147, 148, 341, 323, 324, 427 and 308 read with Section 149 IPC.

- 2. The petitioners have filed this application under Section 438 Cr.P.C.
 - 3. Heard.
- 5. The learned Public Prosecutor has submitted that the petitioners are not involved in any other offence of similar nature. It appears that the injured sustained only minor injuries in the incident. Considering the facts and circumstances of the case, I am of the view that the

custodial interrogation of the petitioners is not necessary in this case. That apart, the petitioners have no criminal antecedent. In the said circumstances, I am inclined to grant pre-arrest bail to the petitioners.

In the result, this application stands allowed, and the respondents are directed to release the petitioners on bail, in the event of their arrest in connection with the above said crime, on condition of each of the petitioners executing a bond for Rs. 40,000/- (Rupees forty thousand only) each with two solvent sureties each, each for the like sum to the satisfaction of the 2nd respondent before whom the petitioners shall surrender within ten days, if not arrested in the meantime, and subject to the following further conditions:-

(i) The petitioners shall report before the Investigating Officer on every Tuesday between 9 a.m. and 10 a.m. for two months and thereafter, as and when required by the investigating officer for interrogation.

- (ii) The petitioners shall not intimidate or influence the witnesses or in any way tamper with the investigation.
- (iii) The petitioners shall not get involved in any offence during the pendency of this case.
