JUDGMENT

"a. issue a writ of mandamus or any other appropriate writ, direction or order directing the 6th respondent to consider Exhibit P4 and take appropriate action thereon with notice to the petitioner forthwith.

b. grant such other reliefs which this Honourable Court may deem fit and proper in the interest of justice."

2. Evidently the issue relates to a degree secured by the 3rd respondent from the Kerala University and the consequential representation filed by the petitioner seeking enquiry into the same.

3. However, today when the matter is taken up, learned counsel appearing for the petitioner submitted that, the subject matter has become infructuous, since the University has already taken a decision on the basis of the representation submitted by the petitioner.

Accordingly, the writ petition is dismissed as
infructuous.
