JUDGMENT

Dated this the 29th day of November 2019

Heard the learned counsel for the petitioners and respondents.

2. Aggrieved by Ext.P6 order passed by the Rent Control Court, Vatakara on I.A No.528 of 2019 in R.C.P No.130 of 2017, the petitioners in the above rent control petition have appraoched this Court. Ext.P1 is the eviction petition, preferred by the petitioners, seeking eviction of the respondents from the tenanted premises. As per Ext.P2 order, an ex parte order of eviction was passed by the Rent Control Court finding that the respondents did not appear on the assigned date. Thereafter, Ext.P3 application was filed by the respondents in the eviction petition (respondents herein) requesting the court below to set aside the ex parte order. That application was filed within the statutory period. In that matter, after hearing both sides, Ext.P6 order was passed. In the meantime, the

eviction petitioners sought the order of eviction executed through the Munsiff's court having jurisdiction as per E.P No.65 of 2019 in the above Rent Control Petition. Pursuant to the order in the execution petition without giving notice to the respondents as required under Order XXI Rule 22 C.P.C, an order of eviction was passed. It is the case of the petitioners that after getting delivery of the property through court they had entrusted the building to another tenant and he had invested huge amounts for modifying the building and started occupying the same. It is contended that if the ex parte order is set aside, the petitioners and new tenant would suffer irreparable injury.

3. After hearing the learned counsel on both sides, we are of the view that the court below cannot be faulted for setting aside the ex parte order as mentioned in Ext.P6. Apprehension of the petitioners is that the property will be restituted by invoking Section 144 C.P.C. It is a matter to

be agitated before the executing court. All the questions relating to application of Section 144 C.P.C to the given facts are left open. We find no merit in the challenge against Ext.P6 and hence, O.P is dismissed.

All pending interlocutory applications will stand dismissed.
