ORDER

The petitioner is the 11th accused in Crime Nos. 550, 551, 552, 553, 554, 555, 561, 564, 565, 566, 567, 569, 571, 572, 573, 574, 575, 576, 579, 583, 584, 585, 587, 588, 589, 593, 595, 601, 602, 603, 605, 606, 607, 609, 611, 616, 622, 745, 746, 747, 750, 751, 763, 768, 769, 782, 783, 784, 792, 793, 794, 795, 796, 801, 816 and 817 of 2017 and 29, 43, 75 and 108/2018 of Tirur Police Station. All the said crimes were registered for the offence punishable under Section 420 read with 34 IPC.

2. The common allegations in the above said crimes can be briefly stated as follows:

The first accused is the Managing Director of M/s.Accomplish Marketing Pvt. Ltd. The said concern started M/s. Thunjath Jewellery at Tirur with the first accused as the Managing Director and accused Nos. 2 to 15 as its Directors. Various schemes were introduced by the company, as per which their customers were encouraged to invest money and they were assured substantial profit by way of interest, dividend and gift in the form of gold. Believing the words of the accused, the victims in the above cases invested money. However, the interest, dividend, gift or profit was not paid by the Company. The money was also not re-paid. Altogether, sixty nine cases were registered against the petitioner. The company received an amount of nearly Rupees Thirty Crores from various persons together.

3. The petitioner has filed these applications under Section 438 Cr.P.C in the above said crimes.

4. The learned counsel for the petitioner has submitted that the petitioner is a handicapped person, who is not even able to manage his own personal affairs and hence it can not be said that the petitioner was in charge of and responsible for the conduct of the business of the Company.

5. The learned Public Prosecutor has also submitted that the petitioner is a handicapped person. Annexure A4 in B.A.No. 6308/2019 is an order passed by this Court in B.A. No.2203/2018 filed by the petitioner herein in Crime No.598/2017 of Tirur Police Station. It appears from Paragraph five of the above said order that the learned Public Prosecutor filed a statement before the High court in

the above said case. The learned Public Prosecutor also produced the certificate of disability of the petitioner issued by the Medical Board, showing that the submission of the learned counsel for the petitioner that the petitioner is unable to take care of even his basic necessities by himself, was genuine. The learned Public Prosecutor has submitted that the first accused played the major role in the offence involved in these cases. The first accused was in custody for a long period in connection with various cases. In some cases, the first accused was granted default bail. It appears that it was only because the petitioner was a Director of the Company that the petitioner was arraigned as 11th accused in the crime. The learned Public Prosecutor has also fairly conceded that the petitioner had no active role in the business carried on by M/s.Thunjath Jewellery. This

Court had already granted the relief under Section 438 Cr.P.C. in favour of the petitioner herein in nine cases. Considering the facts and circumstances of the case, I am of the view that an order under Section 438 Cr.P.C. in favour of the petitioner in the above said crimes will be justified.

In the result, these applications stand allowed and it is directed that the petitioner shall be released on bail in the above said cases, on condition of the petitioner executing a bond for Rs.30,000/- (Rupees thirty thousand only) each, in each of the above said crimes, with two solvent sureties each, each for the like sum to the satisfaction of the Station House Officer concerned, before whom the petitioner shall surrender within fifteen working days, if not arrested in the meantime and subject to the following further

conditions:

1. The petitioner shall report before the Investigation Officer on every Saturday between 9.00 a.m and 11.00 a.m. for one month and thereafter, as and when required by the Investigating Officer for interrogation.
2. The petitioner shall not intimidate or influence the witnesses or in any way tamper with the investigation.
3. The petitioner shall not get involved in any other offence during the pendency of this case.
4. The petitioner shall co-operate with the investigation.
