These writ petitions are filed challenging an order passed by the Admission Supervisory Committee on 23.6.2015. The issue relates to the fee and other amounts being collected for one academic year. Nine writ petitions have been filed by the students of the various institutions and two of the writ petitions are filed by the College itself.

2. The substantial issue involved in the writ petitions are with reference to the fee, i.e., the tuition fees and other amounts that are being collected for the entire course. The Bachelor's Degree course in Architecture is a five year course and as per the Regulations framed by the Council under Section 21 of the Architects Act, 1972, the stage of course shall be the first 3 academic years

or 6 semesters of institutional academic studies and the second stage of the course shall be of 2 academic years/4 semesters including one year of practical training. The contention urged by the students was that the one year practical training does not involve any expenditure for the colleges and therefore the tuition fee, special fee and other amounts which have been demanded are not payable. Whereas, the colleges have contended that in so far as the facilities were still available in the colleges and the faculties should be available for ensuring that the quality of training imparted is in accordance with the curriculum, it is necessary that the entire tuition fee and special fee ought to be collected during the period when the students go for internship as well.

3. This issue was considered by the Committee. The Committee arrived at a conclusion that the

special fee is not payable during the relevant time, whereas the students are under obligation to pay the tuition fee fixed for the said year and accordingly issued a direction that in respect of the students, they need to remit only the relevant annual tuition fee and need not remit any special fee which was Rs.25,000/- per annum.

4. Learned counsel appearing for the students/writ petitioners contended that in so far as the college is not providing any classes during the relevant time, the question of payment of tuition fee does not arise. It is pointed out that the tuition fee has to be fixed by the Committee for every year and when no classes are being taken during the year when the students are sent for practical training or internship, there is no obligation to pay any fee at all. The management, however, contends that though the students are sent

for internship, the entire faculty have to remain there and they have to monitor and supervise the work that is being done by the students and therefore, necessarily the tuition fee as well as special fee are payable.

5. In W.P.(C)No.15034 of 2017, counter affidavit had been filed, wherein the 2nd respondent college had given the guidelines prescribed by the Council of Architecture for conduct of the practical training. The said instructions read as under;

- "1. The practical training of one year duration shall be carried out in the office of an experienced architect registered with the Council of Architecture or trained professional of the relevant field in stage II.
2. The practical training shall be supervised and evaluated by the institution.
3. The Architectural Thesis/Project will be initiated in the seventh semester and completed in the eighth semester.
4. The candidate shall submit a synopsis of the Thesis Project and

the institution will approve this before the candidate is allowed to proceed with the Thesis project.

5. The Architectural Thesis/Project shall be prepared under the guidance of an experienced teacher/qualified professional.

6. The institution shall conduct the internal evaluation stages for the Architectural Thesis/Project with the guide as a co-assessor.

7. A jury comprising of an internal and external examiner and the guide shall conduct the final examination of the Architectural Thesis/Project in the institution at the end of the Tenth semester as a University examination."

6. It is not in dispute that the tuition fee which was fixed earlier, came to be challenged only at a later occasion. Though the students go for practical training, necessarily as mentioned by the Committee, the faculties and other staff of the college would remain there and the college is under obligation to pay salary for the faculties as well as the non teaching staff and they have to meet other expenditure. That apart, the faculty members

have to supervise the internship that are being done by the students, and their consultation, discussion etc. are required for the improvement and evaluation of the work and therefore their participation during the period of internship would in fact permit the college to collect the tuition fee. However, taking into account the fact that no specific classes are being conducted, the Committee came to an opinion that the special fee need not be paid. Having regard to the fact that the Committee, which is a statutory authority, has gone into the entire issue in its proper perspective, we do not find any unreasonable approach being taken in the matter and there is no perversity in the opinion of the fact finding authority. We do not think that we should interfere in the matter in these writ petitions. We confirm the view of the Committee and accordingly, all these writ petitions are
