**ORDER**

**Dated this the 31st day of December 2019**

The petitioner is an accused in Crime No.38/2019 of Chittur Excise Range, for having been in possession of 1.950 kgs. of Ganja, and there by committed an offence punishable under Section 20(b)(ii)B of the Narcotic Drugs and Psychotropic Substance Act.

2. The petitioner pleads innocence and says that some abandoned Ganja was recovered by the police and he being from Tamil Nadu, was deliberately implicated since the real owners of the contraband articles would not be found. There is no case for the prosecution that the petitioner has antecedents.

Considering the quantity of contraband, and the fact that he has no antecedents and that he has been in judicial custody since 20.11.2019,

the petitioner is released on bail on execution of bond for Rs.50,000/- (Rupees fifty thousand only) with two solvent sureties each to the like amount to the satisfaction of the Trial Court and on condition that he shall appear before the Investigating Officer on every alternate Mondays between 9 AM and 12 PM for a period of three months or till the filing of the final report whichever is earlier. He shall not get involved in similar offences during the trial. In case he violates any of the bail condition, the prosecution shall be at liberty to apply for cancellation of the bail.
