Apparently, the issue in this writ petition relates to the approval of the appointment of the petitioner as HSST. However, today when the matter is taken up, learned Senior Government Pleader submitted that, petitioner's appointment as HSST is approved on and with effect from 04.07.2001 as per order dated 09.10.2019.
