Petition under Section 438 of Cr.P.C. praying that in the circumstances stated in the petition filed herein, the High Court may be pleased to enlarge the petitioner on bail in the event of his arrest in Crime No. 65 of 2019 on the file of Uppal P.S. in Malkajgiri Division, Rachakonda in Medchal District in the interest of justice;

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of Sri B VIJAYSEN REDDY Advocate for the Petitioner, and of Additional Public Prosecutor for the respondent, the Court made the following.

ORDER

This Criminal Petition, under Section 438 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A.7, for grant of anticipatory bail in Crime No.65 of 2019 of Uppal Police Station, Rachakonda Commissionerate, registered for the offences punishable under Sections 406, 420, 120B of IPC, Sections 3, 4, 5 and 6 of the Prize Chits and Money Circulation Schemes (Banning) Act, 1978, and Section 5 of the Telangana Protection of Depositors of Financial Establishments Act, 1999.

- Heard the learned counsel for the petitioner/A.7, the learned Additional Public Prosecutor representing the respondent-State and perused the record.
- 3. The specific allegation against the petitioner/A.7 is that he helped the accused No.1 in this crime to shift his company to Uppal, in the month of July, 2018, to the premises bearing H.No.2-1-57/A, Laxma Reddy Colony, Uppal, on a monthly rent of Rs.1,70,000/-. There are allegations of cheating etc. and with regard to purchase and sale of groundnut oil machines, against the accused Nos.1 to 5 in this crime. Having regard to the nature of allegations levelled against the petitioner/A.7 and the gravity of offences, he can be granted bail under Section 438 of Cr.P.C., on some conditions.

- 4. Accordingly, the petitioner/A.7 is directed to surrender before the Station House Officer, Uppal Police Station, Rachakonda Commissionerate, within a period of 15 days from the date of this order. On such surrender, the said Station House Officer shall release the petitioner/A.7 on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties in a like sum each to his satisfaction. On such release, the petitioner/A.7 shall report before the said Station House Officer on every Sunday between 09:00 AM and 10:00 AM, till filing of the charge-sheet. The petitioner/A.7 shall also abide by the conditions stipulated in Section 438(2) of Cr.P.C., and shall cooperate with the investigating officer in the investigation of the case.
- The Criminal Petition is, accordingly, allowed.
 Miscellaneous petitions, if any, pending in this Criminal Petition, shall stand closed.
