These appeals have been filed under Section 14A (2) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Act against the orders dated 10.10.2019 and 27.9.2019 passed by the learned Special Judge, Scheduled Castes and Scheduled Tribe (Prevention of Atrocities) Act Cases, Ajmer, whereby the bail applications filed by the appellants have been dismissed.

Brief facts of the case are that an FIR No.371/2019 was registered at Police Station Christianganj, Ajmer for the offences mentioned therein. During the course of investigation, the accused appellants were arrested. Thereafter, they moved bail

applications before the trial court, who vide impugned orders dated 10.10.2019 and 27.9.2019 dismissed the same. Hence these appeals have been filed on behalf of the appellants.

Learned counsel for the appellants have contended that the appellants are in judicial lock-up since long and the conclusion of the trial will take time, therefore the accused appellants should be released on bail.

Per contra, learned Public Prosecutor has opposed the submissions advanced on behalf of learned counsel for the appellants.

Looking to the facts and circumstances of the case, but without expressing any opinion on the merits or demerits of the case, I deem it just and proper to release the appellants on bail.

Therefore, these appeals are allowed and it is ordered that accused appellants - Deepak Yadav S/o Shri Panchu Ram Yadav, Lokesh S/o Shri Gajanand, Kamal Rao S/o Shri Umrao Rao, Suresh S/o Shri Bhagat Ram, Akash @ Ajay Karan S/o Shri Ramkaran, Manoj S/o Shri Ratan Lal, Biram Gurjar S/o Shri Nandlal Gurjar and Bhag Chand Gurjar S/o Shri Nand Lal Gurjar shall be released on bail under Section 14 A of SC/ST Act in connection with afore-mentioned FIR provided each of them furnishes a personal bond in the sum of Rs.25,000/- together with one surety bond in the like amount to the satisfaction of the trial court with the stipulation that they shall appear before that court on all subsequent dates of hearing and as and when called upon to do so.
