1. The present 2nd bail application has been filed under Section 439 Cr.P.C. The petitioners have been arrested in connection with FIR No.277/2019 registered at Police Station Brahmpuri, Jaipur Metropolitan for the offence(s) under Sections 454, 394, 323 & 34 of IPC and Section 4/25 of Arms Act.
2. Counsel for the petitioners submits that the offences alleged against the petitioners are triable by Magistrate. Counsel further submits that the challan has already been presented in the matter and conclusion of the trial may take long time.
3. Learned Public Prosecutor has opposed the bail application.

4. Considering the contentions put-forth by the counsel for the petitioner and taking into account the facts and circumstances of the case and without expressing any opinion on the merits of the case, this court deems it just and proper to enlarge the petitioners on bail.

5. Accordingly, this 2nd bail application under Section 439 Cr.P.C. is allowed and it is ordered that the accused-petitioners **Kaluram@jeetu S/o Lt. Hariram & Rajesh Kumar Bairwa S/o Lt. Shri Pappu Bairwa @ Ganga Vishan** shall be enlarged on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing as and when called upon to do so.
