## **ORDER**

- [1] Heard Mr. Th. Ibohal, learned senior counsel appearing for the petitioner and Mr. N. Kumarjit, learned Advocate General appearing for the State respondents.
- [2] The relief sought for in the present writ petition is as follows:-
  - "b. as to why an appropriate writ of Certiorari of direction or order should not be issued a direction for initiation of a regular land acquisition proceeding in accordance with Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 regarding the affected land of the petitioner, which are excluded in the list of the direct purchase;
  - c. as to why the Hon'ble Court not issue a direction not to make disturbance, alterations and change of records of right during the process of the land acquisition"
- [3] Mr. Th. Ibohal, learned senior counsel appearing for the petitioner states that the petitioner is the owner of certain extent of homestead land (Schedule-A and Schedule-B lying in compact) situates on the adjacent to west of the National Highway 102 at Waithou Toronglaobi, within village No. 22-Kiyamsiphai, Thoubal District, Manipur. The grievance of the petitioner is that the respondents are attempting to take away the land by way of direct purchase. He refers to order dated 21.02.2020 passed in by this Court in W.P. (C) No. 975 of 2018 wherein direction has been issued to the State Government not to adopt 'direct purchase' but to proceed under the provisions of the Land Acquisition Act, 2013.
- [4] Be that as it may, the petitioner pleaded that he has made a representation dated 31.01.2020 (Annexure-A/7) to the Commissioner (Revenue), Government of Manipur and the District Collector (D.C/Land

Acquisition), Thoubal District, Manipur. However, there is no signature nor proof

of submitting the same to the authority. In absence of such proof of submitting

such representation, objection raised by Mr. N. Kumarjit, learned Advocate

General that the authority cannot decide in vacuum, is sustained.

[5] Accordingly, the writ petition stands disposed of giving liberty to

the petitioner to make a detailed representation with proper acknowledgment

to the officer concerned, who shall, thereafter, decide the same on its own

merit.

Writ petition stands disposed of as above.
