Heard Mr. A. Saring, learned counsel for the petitioner. Also, heard Mr. I. Riram, learned Addl. Sr. Govt. Advocate appearing for the State respondents.

This is a petition, with a limited prayer praying for a direction, directing the Deputy Commissioner, Kar Daadi District, Arunachal Pradesh, to dispose of the representation of the petitioner, dated 13.02.2020, submitted to his Office, on the same day.

It appears from the submission of the learned counsel of the petitioner that the decision of the Keba, regarding the land dispute between the petitioner and the private respondent, came up before this Court in WP(C)No. 644(AP)2017 and this Court after examining the same found it to be not discernable, as to in whose favour the case was decided, therefore, did not interfere with the decision. Placed in such circumstances, the petitioner submitted a representation stated above, to the Deputy Commissioner, Kar Daadi District, praying for an order to conduct a local *mel* to decide the dispute between him and the private respondents. However, it appears that the representation has not been considered and disposed of, ever since.

In view of the facts and circumstances of the case and the limited prayer, this petition is disposed of, with a direction to the Deputy Commissioner, Kar Daadi District, to dispose of the representation of the petitioner, dated 13.02.2020, at the earliest, but not later than 2(two) months, from the date of receipt of a copy of this order.

The petitioner shall submit a copy of this order, along with the copy of the representation dated 13.02.2020, to the Deputy Commissioner, Kra Daadi District, Arunachal Pradesh, within a week from today.
