The Court proceedings have been conducted through Video-Conference.

- 2. Sri Hari Prasad Guwala, a qualified lawyer has filed this petition in purported public interest to plead that although Minimum Wage Advisory Board for Plantation Workers has calculated and recommended minimum wage payable to tea plantation workers in Assam as Rs. 351.33 per day, however only Rs. 167/- per day is being paid. On being questioned by the Court, the petitioner admits that there is a Union representing tea plantation workers which espouses the causes of the workers. Evidently the petitioner himself is not a worker in the tea plantation. It has been stated that his mother used to work in a tea plantation.
- 3. On being confronted with the reason and cause for filing this petition, although the petitioner is not connected with tea planters or workers working in tea plantation and also because there is a Union that represents the workers, learned counsel for the petitioner states that let the petition be dismissed as withdrawn.
- 4. Ordered accordingly.
