Heard Mr. T. H. Hazarika, the learned counsel for the petitioner. Also heard Mr. D. Das, the learned Additional PP, Assam who produced the Case Diary.

By this application under Section 439 of the Cr.P.C. the accused-petitioner namely Md. Guljar Ahmed is seeking bail in connection with North-Lakhimpur P.S. Case No. 989/2020

under Sections 147/148/149/342/325/395/506 of the IPC.

I have perused the Case Diary and the statement of the witnesses recorded in the Case Diary. From the statements so perused no specific acts are attributed to the petitioner in complicity of the offence who was arrested on 22.10.2020. Keeping in view the length of detention of the petitioner, in my considered view no further custodial interrogation of the present petitioner is required as such I am satisfied to grant the bail to the petitioner-accused.

Accordingly, the accused-petitioner, named above, shall be released on bail in connection with the North Lakhimpur P.S. Case No. 989/2020 on furnishing bail bond of Rs.10,000/- with one suitable surety of the like to the satisfaction of the learned CJM, North Lakhimpur on the following condition:-

- (1) The accused-petitioner shall not be leave the territorial jurisdiction of the learned CJM, North Lakhimpur without prior permission from the said learned court,
- (2) The accused-petitioner shall not hamper with the investigation, or tamper with the evidence of the case,
- (3) The accused-petitioner shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court or to any Police Officer.
- (4) The petitioner shall continue to appear before the Investigating Officer of the above mentioned case after every 10(ten) days from the date of first appearance till such time the attendance is dispensed with by the said investigating officer.

Accordingly, this bail application stands disposed of.
