**ORDER** 

## 27.11.2020

Heard Mr. B. D. Konwar, learned senior counsel appearing for the writ petitioner. Also heard Ms. M. Bhattacharjee, learned Govt. Advocate, Assam, appearing for the official respondents.

By briefly stating the factual backdrop in which the petitioner is allegedly facing threat and harassment from the members of the public living in his neighbourhood, he has approached this Court inter-alia praying for an order of police protection.

Mr. Konwar submits that the daughter of the petitioner is to appear in her Pre-Board Examination from Dibrugarh which is scheduled to be held on 01.12.2020. Mr. Konwar further submits that the petitioner would retire from service on attaining the age of superannuation with effect from 30.11.2020. Under the circumstances, if the petitioner is not granted police protection, then his threat perception would come in the way of his daughter's educational career thereby causing serious prejudice to the interest of the petitioner.

Perused the statements made in the writ petition, wherefrom I find that the petitioner has not made any representation/application before the police administration of the Dibrugarh district seeking protection.

If that be so, the prayer made in the writ petition cannot be entertained at this stage. However, considering the nature of grievance expressed in the writ petition, without commenting on the merit of the claim of the petitioner, I dispose of this writ petition by granting him leave to submit appropriate representation before the respondent No.2. If such a representation is submitted

by the petitioner within a week from today, his grievance may be looked into and steps, as may be permissible under the law as well as in the facts and circumstances of the case, be taken by the concerned authority.

Writ petition stands disposed of.
