counsel for the respondent no. 3 and Ms. N. Phukan, learned counsel for the Elementary Education of

the Government of Assam.

2. The father of the petitioner Late Nani Gopal Chakraborty who was serving as a Grade IV

employee in the Elementary Department of Government of Assam in the Cachar district died in

harness on 10.07.2015. On his death, the petitioner submitted an application for compassionate

appointment on 10.06.2016. The only grievance raised in this writ petition is that the said application

of the petitioner for compassionate appointment has not been placed before the concerned DLC.

3. Considering the nature of the grievance, we dispose of this writ petition by directing the District

Elementary Education Officer, Cachar to place the application for compassionate appointment of the

petitioner submitted on 10.06.2016 before the next available DLC of Cachar district. Upon the said

application being placed, the DLC shall pass a reasoned order on its own merit.

4. Writ petition stands disposed of in the above terms.
