**Order No. 4 : Dated 30<sup>th</sup> June, 2020**

Heard Mr. Someshwar Roy, the learned counsel appearing for  
 the petitioner and Mr. Santosh Kr. Jha, the learned counsel appearing on  
 behalf of the respondent-JMADA.

2. This writ petition has been heard through Video Conferencing  
 in view of the guidelines of the High Court taking into account the  
 situation arising due to COVID-19 pandemic. None of the parties have  
 complained about any technical snag of audio-video and with their  
 consent this matter has been heard.

3. The defects are ignored.

4. Mr. Roy, the learned counsel for the petitioner submits that he  
 has already paid the court fee.

5. The office note also suggest that the court fee has already  
 been paid.

6. The petitioner has preferred this writ petition for a direction  
 upon the respondents to pay the amount of retiral dues such as, provident

fund with contributory benefits, Gratuity, Leave encashment, Group insurance, difference of dearness allowance, benefit of 6<sup>th</sup> pay revision w.e.f. 01.01.2006 and benefits of A.C.P. The prayer of interest is also made. He submits that the petitioner was appointed on 02.10.1980 on the post of Health Supervisor and retired on 31.01.2020. He further submits that a representation has already been filed but no retiral dues has been released in favour of the petitioner.

7. Mr. Jha, the learned counsel appearing for the respondent-JMADA submits that if a fresh representation is filed by the petitioner, the same shall be considered by the respondent –JMADA in terms of the scheme made by JMADA for release of such amount.

8. Accordingly, the petitioner is directed to file a fresh representation along with all the credentials on which he is relying within a period of two weeks.

9. If such a representation is filed within the aforesaid period, the respondent JMADA shall consider the case of the petitioner and pass appropriate order in terms of the scheme framed by the respondent JMADA for payment of such amount within a period of six weeks.

10. If the petitioner is found entitled for such benefit, the benefit of the same shall be released in favour of the petitioner within four weeks thereafter.

11. The writ petition [W.P.(S) No.987 of 2020] stands disposed of with the aforesaid directions.
