PER COURT :

- 1] Heard learned counsel for the applicants – appellants.
- 2] These applications are filed seeking extension of time to deposit the amount in terms of order dated 19.7.2019. It is submitted that in terms of the order, the amount was to be deposited before 15.1.2020. Due to financial crisis and non-availability of funds, the amount could not be deposited by the acquiring body. It is further submitted that due to declaration of lockdown, request could not be made earlier for extension of time. Now the funds are received and the applicants are in a position to deposit the amount.
- 3] Considering the cause assigned and the financial crisis the Government and the Departments of the Government are facing on account of declaration of lockdown, I am of the view that request for extension of time to deposit the amount deserves due consideration. I am, therefore, inclined to allow the applications.
- 4] Accordingly, the applications are allowed in terms of prayer clauses [B] and [C]. Time to deposit the amount is extended till 15.7.2020. On deposit of amount, interim order dated 19.7.2019 operating in the matter to remain in operation until further orders.
- 5] Filing of affidavit is dispensed with.

6] Civil applications seeking extension of time are disposed of in above terms.
