# THE HON'BLE SRI JUSTICE D.RAMESH

#### WRIT PETITION No.22465 of 2020

### **ORDER:**

This Writ Petition is filed under Article 226 of Constitution of India, seeking the following relief:

"to issue an appropriate Writ, order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the 4th respondent in not processing the application of the petitioner in connection with agricultural lands in Survey No.1641/4 to an extent of Ac.3.00 cents situated in Munneli Village Fields, B.Kodur Mandal, YSR Kadapa District for issuance of online patta as blatant violation of principles of natural justice, even in spite of the petitioner paying the requisite fee for the same and also making representation to the respondents orally as well as in writing especially on 09-09-2020 which was sent through RPAD on 11-09-2020 as illegal, arbitrary and in violation of articles 14, 19 and 21, 300(A) of the Constitution of India and consequently direct the respondents to mutate the name of the petitioner online by issuing online patta to the petitioner by following due process of law..."

- 2. Heard learned counsel appearing for the petitioner and learned Assistant Government Pleader for Revenue appearing for the respondents.
- 3. As per the averments made in the affidavit, the petitioner is in peaceful possession and enjoyment of the property situated in Survey No.1641/4 to an extent of Ac.3.00 cents situated in Munneli Village fields, B.Kodur Mandal, YSR. Kdapa District, which was allotted by the government, in allotment of the agricultural lands to the landless poor and persons belonging to Schedule Caste Community, in the year 2001 by giving DKT patta and other connected title deeds i.e. 1B Namuna and Pattadar Pass Book. His name is also mutated in DKT Register and he was

inducted into the possession in the same year, since form that

date, he is in peaceful possession and enjoyment of the property

without any hindrance. While so, the petitioner made a

representation to the respondents on 09.09.2020 for mutation of

his name into on-line record, by paying application fee through

Mee-seva for on line mutation. Even after receiving the application

for process, thorough proper channel, till date the 4th respondent

has not processed the same, in spite of several requests made by

the petitioner. Hence, the present Writ Petition.

4. Learned Assistant Government Pleader appearing for the

respondents has stated that the authorities will consider the

application as per the provisions of the ROR Act, if filed under

Form 6A, and they will pass appropriate orders after giving notice

to the concerned persons.

5. Considering the submissions made by both the counsel, the

Writ Petition is disposed of, at the stage of admission, with the

consent of both the counsel, giving liberty to the petitioner to file

an application under Form 6A through on-line. On such

application, the respondents shall consider the same, as per the

provisions of ROR Act, after issuing notices to the concerned

persons and pass appropriate orders within four (04) weeks from

the date of receipt of application. There shall be no order as to

costs. Miscellaneous petitions, if any, pending in this petition

shall stand closed.
