THIS WRIT PETITION IS FILED UNDER ARTICLE 226 OF THE CONSTITUTION OF INDIA, PRAYING DIRECT THE R-4 AND 5 TO CONSIDER HIS APPLICATION DTD. 27.07.2017 VIDE ANNX-D FOR CONSIDERATION FOR SELECTION TO IAS CADRE AND THEREBY INCLUDE THE NAME OF PETITIONER IN THE LIST OF INTERVIEW SCHEDULED ON 3.11.2020 FOR SELECTION TO THE ADMINISTRATIVE SERVICE INDIAN (HEREINAFTER REFERRED TO AS IAS) AGAINST 3 VACANCIES WHICH ARE AVAILABLE TO KARNATAKA NON STATE CIVIL SERVICE (HEREINAFTER REFERRED TO AS NON SCS) OFFICERS IN THE YEAR 2016 IN ACCORDANCE WITH THE INDIAN **ADMINISTRATIVE** SERVICE (APPOINTMENT BY SELECTION) REGULATIONS 1997 AND ETC.

THIS PETITION COMING ON FOR ORDERS THIS DAY, THE COURT THROUGH VIDEO CONFERENCE THE COURT MADE THE FOLLOWING:

ORDER

The petitioner claims to be an officer employed with respondent No.7 as a Joint Controller State Audit and Accounts Department. He contends that the Central Government in terms of its Notification dated 10.02.2017 (Annexure-B) had identified 3 (three) vacancies of IAS Officers to be filled by Non-SCS employees in terms of the 1997 Regulations and

requested the State Government to take further action in terms of the provisions contained in the aforesaid Regulations. The respondent No.4 in terms of its office note dated 06.05.2017 invited proposals from various Administrative Departments in the State of Karnataka for recommending suitable candidates of outstanding merit for selection as IAS Officers. Pursuant to such Notification, the petitioner also submitted his candidature along with necessary documents. The representation of the petitioner was forwarded by the respondent No.7 to the respondent No.6. It is reiterated that the petitioner has all the qualification for selection as an IAS Officer in the Non-State Civil Service category as per the 1997 Regulations. The respondent Nos.4 and 5 considered the names of various Non-SCS Officers for short listing for preparation of the selection list and recommended the name of 15 Officers. Of the aforesaid 15, three persons had withdrawn their request. Thus, there were only 12 candidates in the fray. The petitioner

contends that as per the Regulations of 1997, the State Government has to forward 5 candidates for each vacancy available. Therefore, the petitioner contends that 15 candidates ought to have been nominated by the and only 12 candidates Government were recommended. In that view of the matter, the petitioner submits that his candidature should also be considered for nomination in accordance with 1997 Regulations. The petitioner therefore seeks for a writ in the nature of mandamus to consider his application dated 27.07.2017 (Annexure-D) and before the interview is conducted on 03.11.2020.

In that view of the matter, the respondent No.4 is directed to consider the representation of the petitioner dated 27.07.2017 as expeditiously as possible and preferably before 03.11.2020. Office is directed to deliver a carbon copy of the order to the Government

Advocate to communicate the same to the respondent No.4, forthwith. Writ petition stands *disposed of*.
