The petitioner is the 2nd accused in Crime No.1017/2019 of Pangode Police Station, Thiruvananthapuram, for having allegedly committed offences punishable under Sections 143, 147, 148, 149, 341, 294(b), 323, 326 and 427 read with Section 149 of the IPC.
