J U D G M E N T

The petitioner, who retired from Kerala water authority on 30. 04. 2018 while working as Senior Meter Inspector, is aggrieved by the delay in disbursing the commuted value of pension sanctioned to him. Producing medical certificates, petitioner claims that he has to undergo a surgery which will incur huge expenditure.

2. Sri. Milu Dandapani, the learned standing counsel on instructions submitted that this Court has already issued directions in a batch of cases to make the payment of terminal benefits to the pensioners under the respondents in accordance with the seniority with reference to the date of retirement, because payment is due to several pensioners due to severe financial crunch faced by the respondents.

3. The learned counsel for the petitioner submits that petitioner has submitted Ext.P7 representation before the 2nd respondent and that petitioner would be satisfied with a direction to consider the same.

Accordingly, the writ petition is disposed of, directing the 2nd respondent to consider and pass orders on Exhibit P7 representation taking note of the directions in the common judgment, as expeditiously as possible and at any rate and period

of 2 months from the date of receipt of a copy of the judgment.
