JUDGMENT

The petitioner was initially appointed as UPSA with effect from 1.6.2016. The petitioner on getting confirmation of appointment, was relieved from the Government LP School on 6.6.2016 and he joined the Aided UP School Cheeral from 9.6.2016.

2. It is the case of the petitioner that his proposal for appointment was by mistake forwarded to the fourth respondent, who rejected the appointment by Ext P2 order. The sixth respondent-Manager, preferred an appeal against Ext P2 order. Even though there was delay in filing the appeal, the same was directed to be considered by Ext P4.

3. The petitioner has averred that there are established vacancies in the school to accommodate the petitioner as well as respondents 7 to 9, and that there is no justification on the part of the respondents 1 to 5 in not approving the appointment of the petitioner. The petitioner has filed Ext P10 statutory revision petition before the first respondent challenging Ext P9 order.

The petitioner prays that Ext P10 revision petition may be directed to be considered and disposed of by the first respondent within a time frame.

4. Heard the learned counsel for the petitioner and the learned Government Pleader appearing for the respondents 1 to 5. In view of the limited relief that I propose to grant, I dispense with notice to the respondents 6 to 9.

5. After perusing the averments in the writ petition and after hearing the learned counsel for the petitioner and the learned Government Pleader, I am of the considered opinion that the first respondent is to be directed to consider and dispose of Ext P10 revision petition in accordance with law.

6. In the above circumstances, I dispose this writ petition by directing the first respondent to consider and dispose of Ext P10 revision petition, in accordance with law, within a period of three months from the date of receipt of a copy of this judgment. The first respondent shall afford the petitioner and the respondents 7 to 9 or their authorised representative an opportunity of being heard.
