THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 26.08.2020, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

## **JUDGMENT**

The prayers in the above Writ Petition (Civil) are as follows:

- "i. To issue a Writ of certiorari or any other appropriate writ or order or direction, quashing Exhibit P1 to the extent to which, the land of the petitioner is included as paddy land/ wetland in the Data Bank prepared by the 5<sup>th</sup> respondent;
- ii. To declare the land of the petitioner in the application as unnotified land/dry land and liable to be removed from the Data Bank prepared by the 5<sup>th</sup> respondent;
- iii. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 5<sup>th</sup> respondent to permit the petitioner to remit the fee for Satellite Map and submit FMB, within a time frame fixed by this Hon'ble Court;
- iv. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 4<sup>th</sup> respondent to issue a certified copy of FMB when LLMC demands, within a time frame fixed by this Hon'ble Court;
- v. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 5<sup>th</sup> respondent to apply for Satellite Map and Report, within a time frame fixed by this Hon'ble Court;
- vi. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 2<sup>nd</sup> respondent to issue satellite Map and Report immediately after LLMC applies, within a time frame fixed by this Hon'ble Court;
- vii. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 5<sup>th</sup> respondent to dispose off Ext.P2, the application for excluding the land of the petitioner from Data Bank, after conducting site inspection of the land along with verifying the KSREC Report if available, within a time frame fixed by this Hon'ble Court;

- viii. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 5<sup>th</sup> respondent to dispose off Ext.P2, the application for excluding the land of the petitioner from Data Bank, by inspecting the land and without insisting for FMB/KSREC report, if not available, within a time frame fixed by this Hon'ble Court;
- ix. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the 5<sup>th</sup> respondent to correct the Data Bank by excluding the land of the petitioner from Data Bank, and publish an erratum notification in Kerala Gazette for the same without delay, if the Data Bank was published;
- x. To issue a writ of mandamus or any other appropriate writ, order or direction, commanding the respondents to communicate the orders, steps taken to dispose off Ext.P2, and issue copy of the documents leading to the order without any delay;
- xi. And to pass such other appropriate orders or directions as this Hon'ble Court deems fit and proper in the facts and circumstances of the case."
- 2. Heard Sri.Avaneesh Koyikkara, learned counsel appearing for the petitioner and Sri.K.J.Manu Raj, learned Government Pleader appearing for the respondents.
- 3. The case of the petitioner is that though the subject property continues to be described as 'Nilam/Paddy Land' in the Basic Tax Register (BTR), the same has been converted as 'Garden Land' or 'Purayidom', much prior to 12.08.2008 (date of coming into force of the Kerala Conservation of Paddy Land and Wetland Act, 2008). Further that, the property has been included in the data bank as converted land prior to 2008. That the petitioner has now submitted Ext.P-2 application dated 18.07.2019 before the 5<sup>th</sup> respondent-Local Level Monitoring Committee.

Accordingly, it is ordered that on the petitioner filing Ext.P-2 4. application dated 18.07.2019 for exclusion of the subject property from the land data bank, the 5<sup>th</sup> respondent will take up for consideration the said request made by the petitioner without any further delay and after conducting an inspection of the subject property with due prior notice to the petitioner and after ensuring that copy of the inspection report is given to the petitioner in advance and after following any other procedural formalities and thereafter should afford a reasonable opportunity of being heard to the petitioner through authorized representative/counsel, if any and then should take a considered decision on the said plea of the petitioner for exclusion of the subject property from the land data bank, without much delay, preferably within a period of two months from the date of submission of such application along with a certified copy of this judgment.

With these observations and directions, the above Writ Petition (Civil) will stand finally disposed of.
