JUDGMENT

writ petitions on behalf of Medical Colleges have been filed for issuance of writ in the nature of mandamus to respondent Nos.1and 2 i.e., the Kerala of Health Sciences and Controller University Examinations and direction to the respondent University to the online registration for supplementary open examination for submitting attendance and internal assessment of student admitted by the petitioner with a further direction to allow the students to attend all the examinations.

2. The sum and substance of the writ petition (W.P.(C) No.3702 of 2018) in short is that the students of the aforementioned college was selected from the rank list prepared by the State Entrance Commissioner for admission to the Medical course, for the year 2015. They were given admission pursuant to the application invited by the college and selected them on the basis of their merit. Admissions to the college for the year 2015-16

were made strictly on the basis of inter se merit i.e., on the basis of academic credentials and verified by the University. The University though insisted for approval from the Admission Supervisory Committee.

3. Mr. George Poonthottam, learned Senior Counsel for the petitioner submits that the Admission Supervisory Committee, under Section 4 of Kerala Professional Colleges or Institutions (Prohibition of Capitation fee, Regulation of Admission, Fixation of Non-exploitative Fee and other Measures to Ensure Equity and Excellence in Professional Education) Act, 2006 insisted for the approval for students to register with the Universities for the purposes of Examinations. It was not a legal requirement. It was challenged before this Court and the Division Bench of this Court upheld the said stand of Committee. Against the aforementioned judgment, Special Leave Petition(SLP) converted into Civil Appeal Nos.14025 & 14026 of 2015 has been preferred, which is pending consideration. However, vide interim applications No.9 & 10 of 2016,

prayer was made for participating the examination starting from 04.08.2016. The Honourable Supreme Court vide 19.01.2017 permitted the dated students participate in the examination, but the result was ordered to be declared provisionally as well as the admission to the next semester subject to final decision of the Hon'ble Supreme Court. Vide interim applications No.5 & 6 of 2020 dated 28.09.2020 notification dated 27.08.2020, Ext.P31 (in W.P.(C)No.3702 of 2018) has been placed on record, which is subject to all exceptions, whereby the online registration has started only with effect from 28.09.2020 and last date of receipt of printout of attendance report, internal assessment report was fixed as 10.10.2020. But the students admitted were not allowed to register themselves online as there is no such provision in the web portal. This anomaly was pointed out from time to time and in this background the series of interim applications had been filed. Even the college had to this Court by approach separate writ petition

No.20190/2020, whereby this Court noticing the aforementioned contentions, directed the University to open the online registration of students of petitioner's college as are contained in Ext.P15 list, for submitting their attendance for internal assessment, so as to enable them to register themselves in the examination notified as per Ext.P14 on a provisional basis, pending disposal of the writ petition and granted liberty to approach this Court after the examinations are conducted, for appropriate orders. It is submitted that this impasse is perpetual and is required to be put *in res*. The threat of COVID-19 pandemic has increased ex-prudentially and is very difficult for the parents to shell out during this calamity and seeks the indulgence of this Court for the issuance of appropriate directions to the University.

4. On the other hand, learned counsel appearing on behalf of the university, on instructions from Vice Chancellor/Registrar has been undertaking to this Court that the additionally admitted students from time to time

would be allowed to be registered on online web-portal and there would be an amendment in the web-portal making a closest process for such kind of students to register online for the purpose of attendance and internal assessment and attending the examination. The course would be subject to the outcome of the pending SLP, whereby the goal of the Admission Supervisory Committee is pending consideration. Even the result would also be declared from time to time subject to the condition aforementioned.

5. Keeping in view the stand taken by the University the Registry is directed to place on record the copy of the writ petition No.20190 of 2020 for causing effective order and instructions. W.P.(C) No.20190 of 2020 filed by the another college is also ordered to be disposed of along with these writ petitions.

In view of the undertaking offered by the learned counsel for the respondents on the basis of the instructions received from the Registrar of the University, I

dispose of these writ petitions by issuing directions to the respondents to allow the online registration of the students ie., additionally admitted students in the year 2015-16, through online for the purpose of the attendance, internal assessment and also permit them to sit for the examinations as and when the notification for such process is completed. The result of the above mentioned students also to be declared. Entire exercise on the provisional result, as per the undertaking of the University, would be subject to the outcome of the pending civil appeal, as referred above. Liberty is also granted to the petitioners to file interim application in case any clarification is required.
