THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 30.10.2020, ALONG WITH WP(C).20214/2020(B), WP(C).21926/2020(M), THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

These writ petitions have been heard together on account of the analogues factual circumstances pleaded and the similarity in the prayers sought for.

- 2. In all these cases the petitioners are stated to be students of Law pursuing studies in various Colleges under the Mahatma Gandhi University (M.G. University). They pray that the Semester Examinations, which is scheduled by the University to commence from 04/11/2020, be directed to be done in the online mode, taking note of the guidelines issued by the University Grants Commission (UGC) and the Bar Council of India (BCI).
- 3. The petitioners say that they are seriously aggrieved by the action of the University in conducting the examinations in the physical mode, without heeding to the egregious spread of the COVID-19; and therefore, pray that they be directed to

consider holding of the examinations in the online mode, at the earliest.

4. When this matter was considered by me on 27/10/2020, after hearing the learned counsel for the parties, I had passed the following order:-

"Shri.Rajit, learned Standing Counsel for the Bar Council of India, submits that except in the case of the Final Semester, an online examination is not recognized under the Rules of Legal Education, 2008. He submitted that he will place on record a statement enclosing all the relevant guidelines issued by the Bar Council in this regard.

Shri. Asok M.Cheriyan, learned Standing Counsel for the M.G. University, submitted that the results of the First Semester examinations of the students in W.P(C)No.20214 of 2020, will be published not later than 16/11/2020; and that a schedule has already been published for the purpose of conduct of examinations of the IInd, IIIrd and IVth Semesters. He submitted that online examinations have not been preferred, because the infrastructure and logistical requirements cannot be met and also on account of the stand of the Bar Council as afore stated. He also adds that in order to assuage the apprehensions of the petitioners, they can be allowed a choice of their centre, which should be intimated to the University within a time frame.

The learned counsel for the petitioners seek time to consult with their clients.

List these cases, therefore, on 30/10/2020; within which time the Bar Council shall place their statement on record. I, further direct the M.G. University to inform this Court by the next posting date as to the modus they suggest for the students to choose their examination centre."

5. Today, Shri.Rajit, learned Standing

Counsel for the Bar Council of India, submits that a statement has been filed explaining the stand of his client, wherein, the following have been stated:-

- "1. The writ petition is filed by the petitioners seeking for a direction to the 1st and 2nd respondents to conduct the 2nd, 3rd and 4th semester examinations of 2018 LLB, five year course, on the basis of the marks obtained by them in the internal examinations and also by way of online examination.
- 2. When the matter was taken up before this Hon'ble Court today on 27.10.2020, it was submitted on behalf of the Bar Council of India that different interpretation was given to the circulars issued by the Bar Council of India in respect of the conduct of the examinations, taking into consideration the situation caused due to the Covid-19 pandemic. This Hon'ble Court in the above circumstances directed the Bar Council of India to place on record the issued, for this Hon'ble Court appropriately consider the matter. Accordingly this statement is filed.
- 3. It is respectfully submitted that the Bar Council of India on 27.10.2020 issued guidelines to all the Law Universities in the Country as well as the centers of legal education wherein it was decided to permit the final year students of three yesrs and five year course to appear in online examination and further the university was directed to adopt an alternative strategy for conducting examination for those students who are unable to avail he online examinations for any reason. It was further directed to promote the intermediate semester students on the basis of performance of previous year and marks obtained in internal examination of the current year. The universities were further directed to conduct the end semester examination within a month of reopening of the college. A true

copy of the above guideline dated 27.5.2020 in BCI:D:1401/2020 is produced herewith and is marked as Annexure R3(a).

- The Bar Council of India has on 09.6.2020 issue a press release clarifying the stand of the Bar Council of India. In this press release it was decided by the Bar Council of India to permit the universities to adopt any other appropriate method to satisfy the requirements of regular examination in respect of the final year examinations of LLB students. Under this system the university was permitted to allow students to write a project report/research paper for each paper final year or to adopt a method to double the internal marks of the semester examinations already held for such year. It was further held that in case of final year LLB students, who have not cleared all papers of previous years and are required to sit in the supplementary examination, but, who have been promoted to final year, such final year LLB students may be allowed to write a project report or appear in online examination with regard to the pending/supplementary papers, so that they could also pass within time.
- All students, except final year students, will be promoted on the basis of performance of previous year's marks and marks obtained in the internal examination of the current year. However, it is clarified reopening that after of the colleges/universities, the Universities shall conduct the end semester examination with respect to the year from which they have been promoted, within a reasonable period of time, though, such promoted students shall continue to study in the year to which they have been promoted, and in case, they are unable to pass/clear any such paper of such end semester exam of the year from which they have been promoted, they shall have to clear the same, before they are granted the degree. In the case of students who have been promoted to the final year as LLB students, they shall have to pass all papers in order to obtain their degree/s. A true copy of the above press release dated 9.6.2020

issued by the Bar Council of India is produced herewith and is marked as Annexure R3(b).

- The stand of the Bar Council of India was 6. further clarified in the general council meeting held on 5th October, 2020 and the Bar Council of India clarified that except final vear students examinations of all students shall be conducted within one month of physical reopening of colleges when normalcy resume and when the pandemic situation no longer exists. It was clarified by the that exception Council for conducting examination in the online mode was only for final year LLB students, to prevent any loss of academic sessions thereby putting the students to difficulty. For all other students, examination had to be conducted within one month of reopening of college and that the students will have to clear all the papers before getting their degree. A true copy of the extracts of the minutes of the general council meeting held on 5.10.2020 is produced herewith and is marked as Annexure R3(c).
- 7. It is also brought to the Bar Council of India's notice that some Universities in the country are, on a wrong understanding of Ext.R3(a) to R3(c), propossign to hold the semester examinations in the online mode. It is clarified that the resolution adopted by the Bar Council of India is clear that the option for online mode is only for the final year students and all other semester students, would have to clear their papers by taking part in the examination, which has to be conducted by the universities in the physical mode within one month of reopening of college and that the students will have to clear all the papers before getting their degree."
- 6. **UGC** That said, far the as as guidelines are concerned, there is no doubt t.hat. t.he enables the University same conduct examinations either in the offline

mode or in the online mode or in a hybrid fashion. However, when the Bar Council of India has taken the afore stand, I am of the firm view that I cannot find fault with the University in having preferred the physical mode particularly because, as has been recorded by me in the order dated 27/10/2020, they do not appear to have the infrastructural and logistical requirements to conduct the examinations online, which is to commence on 04/11/2020.

7. Indubitably, all that remains, therefore, are considerations as to the equities to be protected as far as the petitioners are concerned and I had, therefore, asked the learned Standing Counsel for the University through the afore order to inform this Court if the students can be allowed Centres of their choice, so that they do not have to travel very far.

- 8. The learned Standing Counsel for the University, Shri.Asok M.Cheriyan, today informed this Court that the University has taken an apposite decision and that a notification will be issued allowing the students to choose any of the seven Law Colleges affiliated to the M.G. University, as their preferred Centre; and that once they do so, they will be allowed to write examinations in such Centres, subject to the COVID-19 requirements.
- this time, Smt.A.K.Preetha, 9. Αt learned counsel appearing for the petitioners in W.P(C)No.22856 of 2020 and Shri.Abraham P.George, learned counsel appearing for the petitioners in w.P(C)No.20214 of 2020 submitted that the scourge of COVID-19 serious and that many of the students will in position to write not be а the examinations commencing on 04/11/2020. They, therefore, pray that the University be

directed to consider conduct of fresh examinations for such students in future, which may be directed not to be considered as a Supplementary chance but as the main one.

10. Shri.Asok M.Cheriyan submits that this request of the petitioners certainly be considered by the University and that a fresh chance will be offered to every student who is unable to write the scheduled examinations on account of COVID-19 restrictions or such other reasons; and that will be deemed as the the same main examination and not as a supplementary chance.

Taking note of the afore submissions, I dispose of these writ petitions, permitting the University to conduct the examinations - which are scheduled on 04/11/2020 - strictly in terms of the COVID-19 stipulations as are mandatorily prescribed in the health

advisories of Governments of Kerala and India; and the standard operative procedures brought forth by the State Disaster Management Authority and the Health Authorities, thus ensuring that the lives of every student is well protected from the COVID-19 infection, adhering to the social distancing requirements as also other imperative conditions.

The University will also consider allowing students, who are COVID-19 positive and who are desirous of writing the upcoming examinations, separate areas as per the guidelines issued by the Health and Family Welfare of the Government of Kerala dated 22/09/2020 and make arrangements for the same as per the rigour of the said order.

Finally, Shri.Abraham P.George, learned counsel for the petitioners in W.P(C)No.20214 of 2020, submitted that even though the

Second Semester Examinations have been scheduled for the 2018 batch, the schedule of $3^{\rm rd}$ and $4^{\rm th}$ semester are yet to be published by the University.

Shri.Asok M.Cheriyan, learned Standing counsel for the University, in reply, submitted that the schedule for 3rd and 4th Semesters will be published as soon as the 2nd semester examinations are complete, so as not to load the students unnecessarily with simultaneous and multiple examinations.

This is recorded.

The above writ petitions are thus ordered.
