THIS WRIT PETITION (CIVIL) HAVING BEEN FINALLY HEARD ON 30.06.2020, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

Dated this the 30^{th} day of June 2020

The petitioner, who was appointed as per Ext.P1 order UPSA under the $5^{\rm th}$ respondent with effect as from 05.06.2006, is aggrieved by the denial of approval for the period from 05.06.2006. It is stated that her appointment in Ext.P1 was against an additional division vacancy for the year 2006-07 and approval was rejected on account of the ban existed against appointments in additional division vacancies. She was granted approval from 01.06.2011 only on introduction of teacher's package. Seeing that several similarly situated persons appointed during the period of ban were granted approval, the petitioner also submitted a Revision Petition-Ext.P12. By Ext.P13 the Government ordered that since validity to G.O.(P) No.10/10/G.Edn dated 12.01.2010 is pending consideration of the Supreme Court in appeal, the petitioner's appointment cannot be given approval with effect from the date on which she was appointed ie. 05.06.2006.

2. This Court has in a series of cases held that even

in cases where Managers have not executed the bond as prescribed in the aforesaid Government Order, educational authorities can approve the appointment deeming that Managers have executed the bond. Therefore, petitioner's appointment is liable to be approved deeming that the Manager has executed the bond. It will be open to the educational authorities to enforce the provisions contained in G.O.(P) No.10/10/G.Edn dated 12.01.2010 as against the Manager.

Therefore Ext.P13 order is set aside. There shall be a direction to the $4^{\rm th}$ respondent to issue revised orders approving the appointment of the petitioner with effect from 05.06.2006 and grant her all consequential benefits within a period of four months from the date of receipt of a copy of the judgment.

The Writ Petition is disposed of accordingly.
