JUDGMENT

Dated this the 30th day of November 2020

- 1. The petitioner who is appointed as Lab Assistant in an aided school is aggrieved by the denial of approval to his appointment from the date of appointment, that is, 03.06.2013. He was granted approval with effect from 03.06.2013, on the basis of Ext.P3 order.
- 2. The petitioner pointed out that this Court has in the judgment in W.P.(C)No.11033/2014 held that similarly situated persons are entitled to approval with effect from the date of their initial appointment. It is also pointed out that W.A.No.908/2016 filed against the said judgment is already dismissed.
- 3. It is submitted that the State has taken up the matter to the Supreme Court and S.L.P.Nos.15232-15257/19 are pending consideration. As the issue is covered by the judgment of the Division Bench of this Court, the petitioner would be entitled

to get approval in the respective post from the date of his

appointment as Lab Assistant.

4. There shall be a direction to the Regional Deputy Director, the

3rd respondent to issue revised order of approval in respect of

the appointment of the petitioner taking note of the judgment

the date receipt of a copy of this judgment of the Division

Bench and petitioner shall be granted all consequential

benefits. However, this judgment will be subject to the result

of the Special Leave Petition pending consideration before the

Apex Court.

Writ Petition is ordered accordingly.
